SUPPORT THE PARCEL TAX!

Last week, AALA's Representative Assembly convened our Political Action Committee (PAC), and after spirited discussion, the PAC voted to contribute \$10,000 to support LAUSD's Measure E campaign. As you are aware, should the parcel tax pass, it will generate approximately \$100 million per year for four years, and these funds will go directly to schools. The cost to homeowners is minimal—only about \$8.33 per month—and those on fixed incomes will not be assessed.

We strongly believe that this modest investment in our children's education will have important dividends and urge you to become actively involved in educating your school communities about Measure E. One way to do so is to send out weekly Ed Connect messages reminding your constituents to vote and explaining the benefits of the parcel tax.

Following is the letter sent by AALA President **Judith Perez** to the Board President and Superintendent on May 17, 2010, explaining our support.

Dear Board President García and Superintendent Cortines:

AALA is pleased to contribute \$10,000 on behalf of its membership to support the District's Measure E campaign. The check is enclosed. Further please know that AALA has and will continue to provide in-kind services for the duration of the campaign.

To date AALA has provided:

- Information to our membership via our weekly *Update* encouraging them to communicate with their constituencies about the parcel tax and their school needs
- Reminders about Measure E to our members at regular organization meetings
- Distribution of flyers at organization and membership meetings
- Phone banking by AALA staff members
- Communication with the public via media contacts.

AALA members strongly support Measure E, which will provide much needed funding to LAUSD schools. While we understand that this parcel tax will not solve our District's financial crisis, we believe it is essential to ensure student safety, preserve class size, and restore arts education programs.

Should you approve, I would be pleased to present this check at your next Board of Education Meeting on May 18, 2010.

Bravo **Steve Lopez**! On behalf of the “unheralded administrators” of public schools, I thank you for so eloquently explaining the value of the temporary LAUSD parcel tax to help L.A.’s “legions of impoverished youngsters.” As school principals, assistant principals and directors, we know how each budget cut each year to public schools harms kids by raising class size while reducing safety, cleanliness, teacher supervision, counseling and instructional programs such as visual and performing arts. The Associated Administrators of Los Angeles strongly supports Measure E. The parcel tax won’t solve the financial crisis but will mitigate its impact.

CONNECT THE DOTS... TO MORE REVENUE

LAUSD won a major piece of litigation recently when the California Supreme Court turned down an appeal from the County of Los Angeles in the *LAUSD v. County of Los Angeles* case involving redevelopment pass-through monies allocated to school districts. The case was based on a dispute about how to determine the percentage share of property taxes and the appropriate allocation to be received by local school districts. The Court of Appeals held that L.A. County and many other California counties, in fact, improperly excluded Education Revenue Augmentation Fund, or ERAF monies, when calculating local school districts’ share of redevelopment pass-through revenue.

What does all this mean? LAUSD will benefit significantly from this decision. In short, from 1992 until the present, L.A. County has kept around \$100 million in redevelopment property tax revenue that should have been allocated to LAUSD for capital expenditures. LAUSD is now going back to the Superior Court to determine the precise amount owed. From the court decision onward for the next three decades, depending on the economy’s vicissitudes, LAUSD could receive between \$600 million and \$1.5 billion more than expected, or \$20 to \$50 million per year for each of thirty years.

Meanwhile, the LAUSD Board of Education has been issuing Certificates of Participation, known as COPs, to pay for capital goods and has been reimbursing the COPs with general fund dollars that could be used at school sites. In this time of financial crisis, AALA believes that the use of general funds to repay COPs is shortsighted. General funds are essential to support student instruction and safety. Our current budget cuts amount to slash and burn economics—an approach we believe is ill advised, particularly given the District’s aforementioned legal victory.

Once the legal dust settles, AALA urges the Board of Education to pay off the COPs with ERAF money. Use the resultant general fund savings to restore the positions of Assistant Principals at all levels. Return B- and E-Basis assigned administrators to A Basis once again. Make sure that the principal’s job is viable by providing the needed resources to school sites. Rebuild the District’s administrative infrastructure and reduce the existing chaos. Mr. Superintendent and Board Members, please connect the dots to more revenue.

CITY OF ANGELS VIRTUAL ACADEMY OPENS ITS DOORS!

This summer, City of Angels Virtual Academy (COAVA) will provide LAUSD's first online summer school! COAVA will offer a six-week program from July 7 - August 17, 2010, and an accelerated 4-week program July 7 - August 3 (early start calendars) to high school students who need to make up classes required for high school graduation (credit recovery). Twelve semester classes will be offered including Algebra 1, Geometry, English 9, English 10, World History and U.S. History. Among those eligible are ninth-grade students who need to make up Algebra I. The City of Angels Virtual Academy Summer School is a joint venture with City of Angels School, the Office of Educational Technology, Beyond the Bell and the Office of Instruction.

Interested students may enroll with their regular school counselor. Though the regular summer school application period has ended, teachers interested in the online program are encouraged to submit a late application through the summer school online application system. WE NEED AN ABOUT FACE ON TURNAROUNDS

A middle school in Watts in Los Angeles exemplifies the country's failure to turn around its lowest-performing schools, according to its profile in a new report from *Education Sector*. Markham Middle School's student body is predominantly low-income Latino and African American, and in 1997, its average student scored in the 16th percentile in math and the 12th percentile in reading on California state tests. The situation has since deteriorated. In lieu of more drastic measures mandated by NCLB, such as closing or replacing personnel, Markham—as happens in most states and districts—has pursued the less aggressive tactics of hiring consultants, redesigning the curriculum, and creating smaller learning communities. It has also received over \$3 million in state and federal remediation funds. Yet the result is an academic "wreck," according to the report's author **Robert Manwaring**. The Obama administration has made turnarounds a major policy priority, but funding is only the first step. States must follow through and ensure that districts meet the commitments required by these funds, and the report lays out a series of specific policy changes that can be made at the local, state and federal levels to bring this about.
