## MARGUERITE POINDEXTER LAMOTTE

The death of Board Member Marguerite Poindexter LaMotte was a devastating loss to the students, staff and parents of LAUSD as well as the entire world of public education. Ms. LaMotte spent over 50 years committed to students and striving constantly for equality and to level the playing field. She rose rapidly through the ranks of the District and became a noted principal who touched the hearts of thousands of students and fellow educators. Those of us who were fortunate enough to have worked with her remember how outspoken she was and how she constantly challenged the status quo.

Much has been written about her many accomplishments and the profound effect she had on LAUSD, but she was first and foremost a fiercely loyal friend and colleague. She remained a constant supporter of teachers and administrators, never forgetting those in the field or sacrificing her principles for expediency. While serving on the Board of Education for over 20 years, she never wavered from viewing her actions through the lenses of civil rights and equity for the black and brown families she represented.

As tributes roll in from local, state and federal educators, politicians, the public at large, as well as, friends, colleagues and relatives, we realize that her loss at this time is critical. Marguerite was not afraid to take a difficult or unpopular position. She stuck to her beliefs and was the social conscience of the District, the voice of the disenfranchised and more often than not, the one person who could be counted on to seek the input of teachers, administrators and classified personnel.

The members of the Board of Education must decide whether to appoint her replacement or fund a special election. Either choice has grave implications, both political and social. The entire school community needs to be a part of the dialogue that leads to the decision. It cannot be a backroom, political deal that is based on compromises to benefit those individuals with aspirations to higher office and to the detriment of students and families. The unions that represent the employees, parent groups and the public have a right to provide their input.

Marguerite Poindexter LaMotte was an educator for all times, a loyal colleague and friend, a devoted mother and grandmother, deeply faithful to her church and committed to improving the lives of others. She lived a good life and loved to have fun, frequently seen leading the "second line" at the annual Playboy Jazz Festival at the Hollywood Bowl. We will miss you, Marguerite, and know that while someone will ultimately take your space, no one can really take your place. Rest in peace.

## IN MEMORY OF MY PRINCIPAL AND MENTOR, MS. MARGUERITE LAMOTTE

I have had the unique pleasure of being blessed with strong women role models throughout my life who have helped focus me on my academic and professional paths. **Marguerite LaMotte** was one of my mentors. I met Ms. LaMotte when I was a student at Washington Preparatory High School. Despite her presence as the Principal, which commanded respect and admiration, she was always approachable and available. My senior year, I was awarded a college scholarship which provided an opportunity for my relationship with Ms. LaMotte to truly blossom. I was honored to have her at my wedding and to share with her the birth of my daughter and my progression within LAUSD. Even when I began my tenure with the District and became a part of the HR family, I would always be, and she wasn't shy about letting anyone know, "hers".

My last conversation with Ms. LaMotte was just a few months ago. I recall the pride in her voice to hear about my recent promotion. Within days of that conversation, there was a personnel issue at one of her schools and she had a staff member call me for assistance. When I called the staff member back with the resolution, the lady responded excitedly that Ms. LaMotte told her that I was "her girl" and that I would take care of it. It's that type of trust and confidence that she had in her students that always served as a source of motivation.

Her support was endless and a true extension of her pride in her students and belief in their ability to accomplish anything. While Ms. LaMotte will be missed, she will forever have a place in my work and especially in my heart.

## SELECT OR ELECT BOARD MEMBER MARGUERITE P. LAMOTTE'S SUCCESSOR?

As we head into the second week after the passing of Board Member **Marguerite LaMotte**, a burning question is looming: How shall her seat on the Board be filled? The Board of Education has to make the decision whether her successor should be elected by a vote of those residing in District 1 or appointed by her fellow Board Members. This will not be an easy decision as there are strong arguments for each choice. In either case, the chosen person will sit on the Board until June 30, 2015, making key decisions regarding the Common Core Curriculum, Local Control Funding Formula, iPads and the District's 2014-2015 budget.

Board Member **Bennett Kayser** has already released his opinion—advocating strongly for the Board to immediately appoint someone to represent District 1 in the interim before the next general election in 2015. He argues that the constituents of District 1 (641,236 residents, 303,966 voters and approximately 100,000 students at over 150 schools) need to have a voice at the table immediately, saying, "By the time an election process is complete and someone sworn-in, the constituents will have been without representation for far too long." This is a very valid concern, particularly since without the seventh vote, the Board could easily become deadlocked with 3-3 votes.

Another point in favor of appointment is that the cost of special elections (a general and perhaps a run-off) will run into the millions of dollars, a burden the LAUSD would have to bear as it is trying to recover from the recession. Mr. Kayser also feels that a special election would lend itself to undue influences from well-funded outside sources. This is, in fact, another very salient point, because we well remember how former New York Mayor **Michael Bloomberg, Eli Broad**, the Walton Foundation and others tried to buy the last election for members of the Board of Education.

However, appointment is fraught with problems. It immediately lends itself to behind the scenes maneuvering, as pointed out in a *Los Angeles Times* editorial. Ms. LaMotte strongly supported the employee unions and often was at odds with the Superintendent and his reform agenda. Would the current members of the Board of Education appoint someone who shared her views, someone who generally would join the opposing side or someone who claims to be independent? Those doing the appointing were not elected by the constituents in District 1 and are unfamiliar to them, so the natural inclination would be to be suspicious of the appointee unless the person is established and respected in the community and has knowledge of the issues facing LAUSD. However, Board Members notably represent the whole district and are responsible for approving budget, policy and programs.

If the Board Members decide on an interim appointment, it would certainly show sensitivity to the needs of the community and respect to Ms. LaMotte to select a veteran educator. Yet, opponents to an appointment say that it gives that person an advantage when the general election takes place in 2015, placing him/her in a more favorable position.

An appointment process can obtain from elected officials past and present the criteria to be used in selecting the best person for the position.

This issue will probably arise at the meeting of the Board of Education on December 17, 2013. We hope that the discussion will provide time for input by the various stakeholders in LAUSD and that the Board Members will make a deliberate, wise and well-informed decision.

## HEALTH BENEFITS FAQ

### **TOPIC: MEDICARE PART B – ALL RETIREES 65+ MUST PAY PREMIUMS**

**As a District employee, I've never paid premiums for medical coverage. Doesn't the District continue covering me even as a Medicare retiree?** Yes, the District provides eligible retirees with lifetime health benefits. However, in order to retain their District medical benefits, retirees at age 65 must enroll in and pay Medicare B premiums. Part A is required also and will be addressed in a future *Update* issue.

**What does Medicare Part B cover?** Medicare Part B covers outpatient services from doctors and other outpatient health care providers, ambulance services, home health care, durable medical equipment, some preventive care and many more medical services.

**What is the Medicare Part B premium for 2014?** The standard Medicare Part B monthly premium is \$104.90 in 2014, the same as for 2013; however, the amount you pay is based on your 2012 tax return. Medicare retirees with incomes higher than the standard threshold will pay an additional income-related monthly adjustment amount (IRMAA), as shown below:

**What are the 2014 rates for the income-related monthly adjustment amount (IRMAA) for Part D--prescription coverage?** If you are enrolled a Medicare Advantage plan—Kaiser Senior Advantage, Health Net Seniority Plus, or UnitedHealthCare Group—the amounts are shown on the chart below. Remember that this payment is required despite the fact that LAUSD Medicare retirees must not enroll in Medicare Part D. **Anthem Blue Cross EPO Medicare retirees do not pay any Part D IRMAA amounts.**

## FAREWELL, JACK MOSCOWITZ

**AALA President Dr. Judith Perez made the following comments at Jack Moscowitz' funeral on December 12, 2013**

**Jack Moscowitz** was our dear friend and colleague. He had a long and successful career in LAUSD, serving our students for nearly 35 years as a teacher, coordinator, assistant principal and principal, beginning in 1959. He began as a teacher at University High School and retired as Uni's principal in 1993. In the 20 years since his retirement, he has worked continuously, supporting, mentoring and defending hard-working administrators. He represented AALA members on District committees, including the multicultural committee, was a leader of the Association of Jewish Educators and Executive Director of ACSA Region XVI.

In 2007, Jack received AALA's highest honor, the President's Award for service.

When I was elected President of AALA nearly five years ago, Jack called me and said two things: "Congratulations!" and "How can I help?"

Jack worked with AALA for many years, first as a consultant and then as a field representative. While he was always an outgoing, funny and charming person, he ensured due process for and fiercely defended AALA members whose contractual rights were violated. His colleagues didn't know much about this aspect of his work because the cases were confidential. Most importantly, to those whose professional lives he defended, he was a great listener and patient adviser. He provided honest, stern counsel and a shoulder when needed.

When our office informed AALA members of Jack's passing, we received an outpouring of e-mails and phone calls expressing shock and deep sadness. I'd like to quote four of them:

"Jack was my mentor as a new principal. He talked me through a lot of the craziness in the District. I'll miss him deeply."

"Jack was one of LAUSD's finest gentlemen. I loved working with him and will miss his excellent judgment and unfailing moral compass."

"Jack was always most concerned for the well-being of the leaders of our schools, those we supervise, those we serve. He was a genuine soul."

"Oh, no! Where will we get our restaurant and movie reviews now?!"

At AALA's alumni luncheons, held twice each year, Jack was our go-to guy to deliver the "In Memoriam" section of the program. He unfailingly spoke eloquently about those colleagues who have left us, quoting ancient sages, poets and current stand-up comedians. For Jack I'll quote the well-known Hebrew proverb: "Say not in grief he is no more but live in thankfulness that he was." Jack will be missed by all.
